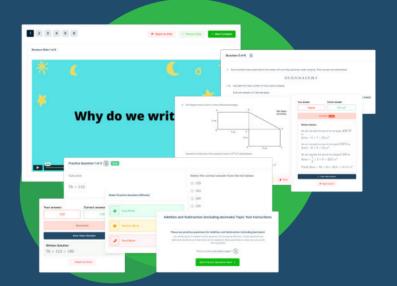

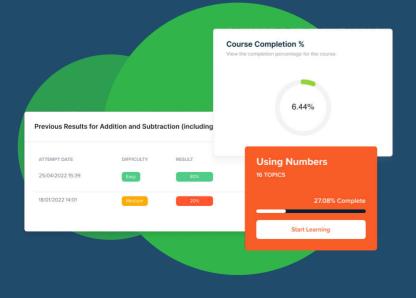

Document 1

Report on Roadside Tree Removal in Weyton

1. Proposal

- a) Weyton Council plans to remove 2,100 roadside trees over the next three years.
- b) 'Della Tree Care (DTC)' has been appointed by the council to carry out the tree reduction scheme.
- c) DTC and the council's Environmental Department will work together to identify which trees are to be removed.
- d) Residents of roads where trees are to be removed will be informed by the council when work will commence and of any parking restrictions during the work. They will also receive communication from DTC explaining the removal process and the reason for removing trees in their road.

2. Reasons for tree removal

- a) Many trees and tree roots are damaging both pavements and road surfaces. This can cause severe problems for:
 - i) pedestrians with mobility issues and those who are visually impaired
 - ii) certain road users, such as those on motorbikes, bicycles and mobility scooters
 - iii) people with pushchairs and those using wheelchairs.
- b) The number of road traffic accidents with vehicles hitting roadside trees has increased by 35% in the past five years¹.
- c) The number of trees with disease or damage has resulted in a 20% increase in essential removal over the past decade².
- d) Residents and road users are facing greater risks of branches coming loose and falling, especially during strong winds.
- e) The council has seen a 15% increase in the cost of maintaining roadside trees this year alone. At the same time, the council's budget has been cut by 20%³ overall.

3. Appeals

- a) Residents will have the right to appeal against the removal of any tree within 30 metres of their property. Their complaint will be considered by the council who will issue a binding decision within four days of receiving the complaint.
- b) DTC will not be involved in the Appeals Procedure, except to offer expert advice to the council.

Teresa emphasises her positive opinion of urban tree removal, using exclamations like 'At last!'. She also emphasises the negative impact that the trees are having on the community, explaining that 'the tree roots sticking out of the pavement mean I can't use my child's buggy safely'.

Document 1 similarly emphasises the negative impact of the trees on the community. While Teresa uses a personal anecdote to achieve this, Document 1 uses a range of impersonal facts and statistics like 'The number of road traffic accidents with vehicles hitting roadside trees has increased by 35% in the past five years'.

While Teresa uses descriptive methods such as adjectives to convey her opinion that trees in the countryside are 'nice to look at', Document 1 only considers the negative aspects of trees, and does not include a range of adjectives or personal opinions.

16 Analyse **all three** documents and explain which is the **most** biased. Provide examples from all three documents to support your decision.

Document 2 is the most biased, as it is a persuasive advertisement written by a forestry company. The writer highlights the merits of the company, explaining that their 'aim is to help local people' and using the rule of three to emphasise that they have 'friendly, considerate and fully qualified' workers.

Document 1 is the least biased as it adopts a formal tone and presents facts and statistics with very few personal opinions or adjectives. It gives the option for residents to 'appeal against the removal' of trees, so is not heavily biased towards their removal. Facts like 'Weyton Council plans to remove 2100 roadside trees' mean that the document is principally informative rather than persuasive, and is therefore less biased than Document 2.

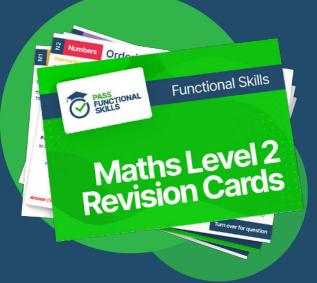
Each contributor to Document 3 is somewhat biased, but overall, the document is less biased than Document 2 because it gives a balanced range of opinions. While Harri is 'horrified' at the prospect of cutting down trees, Teresa is pleased that 'now things are happening' and the trees are being cut down.
