
### Dear Sir/Madam,

I am writing to make a noise complaint about my neighbours at 49 Oxberry Way. This is a letter that I did not want to write, but I have been left with no choice.


My neighbours have lived in their house for many years, and we have enjoyed many summer barbecues together, but recently there have been some problems with the noise that I have not been able to solve.

### **Examiner comments:**

- The writer uses the appropriate format for a letter (address of sender and recipient, as well as a formal opening and closing)
- The letter uses persuasive techniques (for example saying how important it is for babies to be able to sleep) and repetition (if the baby doesn't sleep, the mum doesn't sleep)
- The text also tells the story of the events in a clear way, even describing things Sandra did before the problem started

The construction of a theme park has been proposed within a mile of your town, Stiven.


Information from the company's website is given in Document 1 which you may find useful for your review.


### **Examiner comments:**
